Regulations:	<p>G Mark is now a requirement for Toys and Low Voltage Electrical Equipment and Appliances being sold into member countries of the Gulf Standardization Organization (GSO) [Kingdom of Saudi Arabia, State of Kuwait, Kingdom of Bahrain, Republic of Yemen, State of Qatar, Sultanate of Oman and State of the United Arab Emirates (UAE)] as defined within the Low Voltage Technical Regulation, BD142004-01 and the Toys Technical Regulation BD131704-01</p> <p>Under G mark requirements, manufacturers must choose a single notified body to evaluate product technical design, verify that applicable technical regulations are met, issue an evaluation report, and G mark type certificate to ensure the manufacturer has manufactured the product in accordance with technical specifications of a standard and essential requirements of the regulation as well as authentication of the SASO Energy Efficiency Labelling before issuing the G mark Type certificate.</p>

List of products that require Quality Mark Certificate	
The below product types fall under G-Mark Technical Regulations BD-142004-01 + BD131704-01 and require a valid G-Mark to be listed on the GSO Conformity Tracking System (GCTS) and a Gulf Type Examination Certificate (GTEC). The G-Mark certificate is needed in order to apply for the registration in the new SABER system which mandatory now.
